Conducts health education in collaboration with state and county public health, Indian Health Services, primary health care providers, Navajo Nation Health services; participates in community outreach activities; attends meetings, trainings, in-services and conferences; maintains Quality Assurance Standards; Coordinates and designs program planning modifications, material development (i.e., brochures, power point presentations, flyers, etc.) and other special projects; prepares required reports and assessments; provides educational presentations as requested.

Design and conduct evaluation and diagnostic studies to assess the quality and performance of health education program and project; Prepare and distribute health education material, including reports, bulletins, visual aids, providing program information of health education needs, conducts media campaign, designs brochures, pamphlets and handouts.

Develop, coordinate and facilitate lesson plans for group classes, individual presentations utilizing a variety of health education curriculums such as native Lifestyle Balance, American Association of Diabetes Education, SPARK, PAK, Grocery Tours, Healthy Heart, Dine' Power Plate, etc.

Collaboratively works with wellness center staff on client education for diabetes education, nutrition education and physical activities as they relate to healthy weight loss (this included BMI's and screenings). Implementation of health education curricula's of focusing on diabetes disease, basic nutrition, implementation of physical activities for healthy lifestyle changes. Most importantly, serves as a resource in their service area. Other duties as assigned.
