Title VI programs are funded through Part A/B and/or Part C grants for the provision of nutrition, supportive services, and caregiver support services for American Indian, Alaskan Native, and Native Hawaiian elders. Currently, grants supporting the Title VI response to COVID-19, including CARES, FFCRA, and/or Supplement 5, also may be used to fund some portions of Title VI programs.
